Offshore travel information for travellers to Aker BP's installations

As of 25 September 2021, Norway's pandemic management has entered a new phase, "Normal workdays with heightened preparedness". The Norwegian population over age 18 has also had the opportunity to be vaccinated.

This satisfies Aker BP's criteria for moving to the next stage of our normalisation plan.

The Offshore Travel Instructions will therefore be discontinued as of Monday, 4 October 2021. This also means that pre-flight talks with the nurse and mandatory Covid-19 testing for everyone will be discontinued.

This memo is intended to provide information to those **travelling offshore to Aker BP's installations** from 4 October 2021.

Travel from abroad and mandatory quarantine

Health-related questions

Aker BP has established an advisory service to answer health-related questions in connection with travelling to Aker BP's facilities. The questions will be answered by nurses and physicians. The service can be contacted via e-mail utreise@akerbp.com.

Travellers who are in quarantine, or have symptoms of respiratory infection

If you are in quarantine, have symptoms of respiratory infection, or have an unclarified infection situation yourself or in your household, we ask that you contact the offshore travel nurse well before your scheduled departure.

Personnel who are cleared by the nurse to travel offshore shortly after having a respiratory infection must be tested for Covid-19 (and the flu) prior to departure. This can be done using municipal services where you live, using private services or at Clarion Air, Sola.

Travellers or households that have recently had a Covid-19 infection

If you or a member of your household have had a Covid-19 infection in the last 14 days, you must contact the offshore travel nurse well before your scheduled departure.

Hotel

Travellers with a need for hotel accommodations prior to offshore travel can use the hotel of their choice, but Clarion Air will remain available to Aker BP's travellers. Accommodations can be booked in the ordinary manner.

Travellers subject to mandatory entry quarantine at a quarantine hotel can choose to spend this time at the municipal quarantine hotel or at Clarion Air, Sola.

Heliport and helicopter

Report at the heliport no earlier than two hours before departure.

Information will be posted at the heliport regarding relevant requirements for the use of face masks at the heliport and during flights. The same requirements will apply for flights both to and from the facilities. Face masks will be distributed at the entrance to the heliport as long as this is a requirement.

Offshore

Be aware that Aker BP practices somewhat stricter infection control measures offshore than the broader society on land. Pay careful attention to the rules in force on the installation you are posted on.

Remember that good hygiene and distance when this is possible will help prevent all types of airborne infections.
