24.0	<p>We have extended the refresher period for Fittings and smallbore tubing systems from 4 to 5 years to align with the new requirements in the revised Offshore Norge 143 guidelines.</p> <p>The wording in the IWCF requirements has been adjusted: both the intervention personnel requirement and the D&W requirement now explicitly include "Levels" in their titles. For CT operators we have changed the requirement to level 3 and for CT overall supervisor and supervisor we have changed the requirement to level 4.</p> <p>In chapter 8.3.16-8.3.21 we have replaced the "EX safety and awareness – petroleum industry" course with "EX for ISS disciplines". The requirement "EX Safety and Awareness – Petroleum Industry" has been removed for all roles that already include "EX Safety and Awareness for Mechanical Disciplines – Petroleum Industry".</p> <p>In chapter 8.3.26 We have established a new role called Operator and Maintainer of Potable Water Systems.</p>

	In chapter 8.3.17 we have changed the title of the requirement from “Training in accordance with module 1, module 4 and additional module 4.2 in the NS 9700-1:2016 (chapter 5)” to “Scaffolder (Offshore Norge 105)”.
23.0	In chapter 8.5.1 we have added “IWCF” alongside “IADC” to align with all other roles that require this competency within drilling and wells. In chapter 8.1.9, we have omitted the Alvheim asset, as they currently do not operate any MOB boats.
22.0	In chapter 8.1.12, the refresher period for Acute (Medical) Skills training and the DHLR requirement have been updated to a yearly refresher, as NUI personnel do not participate in module trainings offshore. In chapters 8.6.2, 8.6.3, 8.6.4, 8.6.5, and 8.6.6, the IWCF/IADC requirement has been renamed to "Well Control for Intervention Personnel IWCF". Additionally, in chapters 8.5.2, 8.5.5, and 8.5.14, the RVK course for D&W has been removed, as this course is no longer available.
21.0	In chapter 6 we have added a paragraph that explains in greater detail what Aker BP organizes and pays for in terms of courses for contractors and hired personnel.

5 General competence management requirements

Competence management is of critical importance for COMPANY, thus the requirement for CONTRACTOR to comply with competence requirements as set forth in this document and other contractual obligations. The purpose of this document is to ensure that CONTRACTOR supplies personnel comply with COMPANY's minimum requirements for competence.

CONTRACTOR shall perform the work in full compliance with all provisions herein, or subsequent revisions thereto for the duration of the CONTRACT and any CONTRACT options periods or CONTRACT extensions.

CONTRACTOR shall be responsible for ensuring that all personnel understand and operate in accordance with the principles and requirements of the competence management provisions herein.

According to CONTRACT's appendix on Administration Requirements, CONTRACTOR shall have a documented competence assurance system in place that demonstrates commitment to continuous improvement.

6 Administration of course participants on courses and training

All required courses and training for CONTRACTOR personnel shall be organized and paid for by CONTRACTOR except for:

- Emergency Preparedness Co-Training (samtrening)
- COMPANY customized training / courses

COMPANY will administer participation for CONTRACTOR personnel on the courses listed above. Additionally, COMPANY will also arrange and cover the cost of any courses required of contractors or consultants that exceed the scope of Chapter 8.

7 Common competency requirements applicable to all roles

- Basic safety training (according to Offshore Norge guidelines 002) (Offshore travel requirement)
- Valid health certificate (Offshore travel requirement)
- WP/SJA (Offshore travel requirement)
- Aker BP SAFER course (Available via Aker BP's [Trainingportal for contractors](#))
- Relevant professional certificate of apprenticeship
- Fall protection according to NOG 113/NS -9610 (If applicable). Retraining every 4 years.


In addition, everyone shall be familiar with COMPANY's safety standards and values.

8 Competency role requirements

If you cannot find the requirements for a specific role, common competency requirements in chapter 7 shall apply. In addition there must be a case-by case evaluation by requestor who verifies that the CONTRACTOR fulfils the criteria to perform the planned work in a safe and prudent manner.
